The quilt top is ready to be quilted as soon as I finish the back.

This is a very important meeting since we are having elections and will vote on by-laws changes and a new budget. Please plan to attend if you can, or get your proxy to someone (or the board) if you cannot attend. I know we have a number of members who are traveling, and we need to meet our quorum of 21 members in attendance in order to hold the meeting. Both Ann and Karen Smith will be in the air during the meeting as they return from a Judy Neimeyer trip to Montana. Marcie will be running our meeting.

Be sure to look over the by-laws changes that were sent out before the last meeting so you're ready to vote. If you have questions, please email ccqjuneau@gmail.com, and Debbie will respond.

In addition, the church has informed us that we have exceeded our storage capacity upstairs, and we need to get it cleaned up. Marcie is asking members to stay after the meeting for an hour to help clean up and organize the excess fabric so we can get back in the church's good graces. She will take whatever is non-quilting fabric to Salvation Army and donate it. Marcie has also suggested that our Christmas party supplies be moved to the storage unit if they are still upstairs.

**BY-LAWS REVISIONS:** Many many thanks to Karen Paulick and the by-laws committee who spent countless hours pouring over our by-laws in an effort to make them more concise by removing things that belong in other areas (policies and procedures). Since our by-laws are a legal document that have to be filed with the State and with the IRS, they need to include only items that we must meet legally. In addition, unless it is an emergency, our by-laws can only be changed at our annual meeting in even numbered years.



# CAPITAL CITY QUILTERS SEPTEMBER 21, 2024 DRAFT MINUTES

**PRESENT:** President Ann Lind, Vice President Marcie Benvin, Secretary Dixie Alms and Treasurer Debbie Germain (via zoom).

**Members: Karen Smith,** Christine Moleski, Deborah Johnson, Robbie Stell, Lindsey Cassidy (new), Terri Bonnell, Della Koelling, Louise Miller, Elaine Mahaffey (new), Heather Ramseth, Judy Morley, and Ida Eliason.

**Via zoom:** Karen Paulick, Judy Macnak, Clare Brooks, Shannon Dilley, Mindy Henricksen (at 10:50).

**Proxies:** Sandra Bleicher and Amy Kesten.

The food bank people locked the church doors making it impossible for anyone else to join the meeting in person. Someone let Krisi Selvig in at 11:20 am.

President Ann called the meeting to order at 10:40. We have a quorum.

**New members:** Lindsay Cassidy and Elaine Mahaffey joined today.

**Minutes:** July minutes were approved without correction.

**Treasurer's report:** Debbie's treasurer reports were in the newsletter. Today, she gave only the beginning and ending balances and reviewed our finances based on our budget. We have not expended all that we budgeted; some items are over budget; some are under. We got the storage unit cheaper than we estimated. Debbie is working to finalize our books for the annual audit.

**UFO REPORT:** Sandra is not here. We had one participant (Judy Morley) who completed everything she had in her contract. She has a Changing Tides gift certificate waiting for her at the store. UFO contracts will start again in January (or sooner).

**COMFORT QUILTS:** Judy Morley reported that she is in the middle of quilting several quilts. She has several in her car to return to people for binding but was unsure how many. Louise asked for clarification. Comfort quilts (50" x 60") are made and given to people in stress. We donated to Hawaii after the fire on Maui, to Bartlett Oncology, to Cancer Connection in Seattle for local people undergoing treatment and to other local cancer patients. Comfort quilt tops are made by members and are quilted by Judy. Then, they are returned to a meeting for people to sew on binding and labels. Larger quilts are sent to Cancer Connection in Seattle. Judy needs quilt tops; Debbie will make and send her more labels. Judy purchased a bolt of batting and will submit the receipt to Debbie. Ann collected donated yardage from the teacher at Dzantik'i Heeni following the building's closing. She asked members to stay after the meeting to help cut one yard pieces to put into kits for comfort quilts. We will be cutting a focus fabric, a light and a dark fabric for a 3-yard quilt kit. Ann also has free patterns that will be included in the kits. The individual quilter can cut the fabric as needed for a comfort quilt.

**CHRISTMAS PARTY:** Christine Moleski and Mindy Henricksen are planning our Christmas Party for Saturday, December 7 from 2-4:30 pm. We will have Bingo, Poke a Tree, a pot luck and lots of items up for auction. Christine said they are looking for donations for the auction; if you have anything to donate, please contact either Christine or Mindy. They asked that their budget be the same as last year; Debbie asked when they need money.

**NOMINATING COMMITTEE:** Marcie said she and the committee made a lot of calls. If there are no nominations from the floor at the October meeting, Ann, Debbie and Dixie are willing to remain in office. Marcie will be very involved in the planning of the quilt show, so we are looking for someone to take the Vice President's position. Elections are next month. Nominations can be made from the floor at the meeting.

**QUILT SHOW COMMITTEE:** Christine Moleski and Marcie Benvin are chairing the 2026 Quilt Show with the help of Sheila Box and Mindy Henricksen. The first task is to choose a date and secure Centennial Hall. The team is asking for donations for the silent auction. Our last show cost about \$9,000. Our goal is to cover the show's expenses.

The show takes place every two years and takes about 1.5 years to put together. It takes a team of volunteers to pull off the show. In our proposed policies, the committee is kind of laid out as suggested by the by-laws committee: marketing, set up/clean up, auction table, sales table, quilt entries/check in; biographies, vendors, ribbons (Debbie and Dixie), volunteers for demos and door duty, and other tasks as they arise.

**BY-LAWS:** The committee worked hard, and Karen Paulick made lots of suggestions. Wording has been updated for current technology. Debbie and Karen worked for hours taking procedures and policies out of the by-laws which is a legal document that has to be filed with the State and the IRS for licensing and our 501c3 status.

Our by-laws can be changed only in even numbered years during our annual meeting. Procedures and policies can be changed at any time. Debbie sent out the current By-laws and the proposed By-laws last night. Please be sure to read them all before next month's voting.

The changes we received last month are incorporated into what Debbie sent out last night. Debbie expressed her appreciation to Karen for all her work. Ann added that Karen got the committee on the right track. If you have questions or see something that needs to be added or changed, contact Ann or Debbie through the CCQ email address.

We will vote on the By-laws but not on the policies and procedures.

**PILLOWCASES:** Shannon reported we have been donating to four agencies that she now has on rotation. She added that she cannot make all the pillowcases that are needed. We are currently 32 shy for the need at the Pioneer Home and asked if members still want to make pillowcases. It was said that as a 501c3 organization, we are required to do charitable projects (which includes our pillowcases and comfort quilts). Christine added that the quilt show provides demos and asked if we have unlimited fabric. She suggested we not supply so many agencies. Ann said we've fallen off the wagon and need to refocus on our charitable donations. Shannon said Housing First usually needs only one or two; and the Johnson Center hasn't needed any in months. She asked if it is better to finish what we currently have in stock. Ann noted that we have 80 members and felt we should be able to do both. Shannon asked Marcie if she knew if we put away any pillowcases after the quilt show. Did they go into our storage unit? If they did, we need to get them out since they were made for children and for AWARE. We need to schedule and hold some sew-ins. Laurie Adamson would know if there are any in storage. Debbie said the stuff in the totes that went to storage were things that didn't sell at the show. Judy Morley said she needed the quilt hangers that Bruce made for the sales table. Ann will go to storage and get the pillowcases and quilt hangers. (Deborah Johnson left.) Debbie commented that when we make a profit on the quilt show, she doesn't know if we can call it charitable. Marcie pointed out that the money does go back into charity.
